### Background

- The WHO's International Classification of Functioning, Disability and Health (ICF) is increasingly being used as a conceptual framework to plan goals and points of entry in developmental interventions.
- With children, young people and their families being central to the decisionmaking process, how can the ICF be adapted to be user friendly and acceptable to a wide range of people?

  Building on the ICF, the paper "The F-Words in Childhood Disability: I swear this is how we should think" transforms the domains within the ICF into ideas that are fun and easy for children and young people, families and service providers to complete and use.

- ... used as an ice-breaker by families who are new to 'the system' and feel overwhelmed.
   ... personalised with specific details of how the

  ... a working document updated as needed.
- ·...translated by clinicians into ICF language for assessment and monitoring children's progress
